- 3. Ownership of/Authority over Horse.
- a. Boarder represents and warrants that they are the owner of record of Horse, or that they have express authority of the owner of record to enter into this agreement with Stable. If Boarder is not the owner of record of horse, Boarder nonetheless agrees to be fully bound by the terms of this agreement, and liable for all sums hereunder.
- 4. Boarding Fee. Board is due on the 1st day of each month. Payment received after the 7th of the month will be subject to a \$10 late fee, plus \$5/day for each additional day thereafter on which Board plus accrued late fees remain unpaid. There will be a \$10 charge for returned checks. Checks or cash will be acceptable forms of payment.

5. Stable's Services.

- a. Stable agrees to provide a stall for the horse which will be mucked daily if contract for stall board is signed.
- b. Horse will be provided with daily pasture turn-out for stall boarders; however, Stable cannot guarantee a given schedule for turn-out. Turn-out will be weather-dependent.
- c. Stable will administer any medications and additional feed as requested by Owner at Owner's expense of buying the feed and/or medication. \$25 discount will be applied to board each month if the owner provides and pays for their own feed.

- d. Stable shall have the right to use reasonable and customary restraints and training implements to move Horse should they be necessary. For example, Horse refuses to move or becomes a danger to itself or others. Further, if Horse becomes a danger to itself or others, Stable need not muck Horse's stall or provide turn-out time.
- e. Blanketing will be provided during the cold months with blanket being at Owner's expense.
- f. Application of bandages and wraps will be provided with the cost of supplies being the Owner's responsibility.
- g. Horse will be provided twice daily feeding of Alfalfa pellets with all other supplements and feed being at Owner's expense.
- h. Fescue hay will be provided as needed, any other desired hay is purchased at owner's expense.
- i. Access to round pen, barn, arena, and trail is available to all Boarders.
- j. Holding for vet and/or farrier for a fee of \$5.00 per time unless boarder is there to accompany.
- k. Transportation to vet and/or farrier for a fee of \$10 per trip.
- I. Extra shavings may be provided upon request for \$5.00 each extra bag.
- m. Dewormer will be administered twice yearly, once in the spring and once in the fall for \$5.00 each time in addition to the cost of the dewormer. Dewormers will be rotated unless another Dewormer is otherwise requested by Owner. Owner has option to administer own dewormer as well. If deemed necessary by vet or stable, additional dewormers may be given.

- n. Hosing for injuries or post-workout is provided for \$10.00/time.
- o. The cost of materials for injuries, illness, and prevention of such will provided at Owner's expense.
